On motion made by Mr. Cafone, seconded by Mr. Pelaia and unanimously approved by the Board, the meeting recessed at 5:03 p.m.

### APPOINTMENT OF AUDITOR - 1999/2000 School Year:

There was discussion of what the auditor's responsibilities are to the school district. Mr. Moscaritola stated that he thought the Board was attempting to try to pick the best person for the best price. Mrs. Russo felt it was the Board's job to look at the recommendation from the administration. Mr. Pelaia stated that he felt that unlike a personnel appointment this was the Board's appointment.

There were questions and answers about different proposals that had been received by Mr. Sincaglia.

# Dr. Casale entered during this discussion

Mrs. Russo presented and moved the adoption of the following resolution, seconded by Mr. Picciano. Upon being put to a roll call vote the resolution was defeated with Mrs. Fleitell, Mr. Picciano and Mrs. Russo voting aye and Mr. Cafone, Dr. Casale, Mr. Pelaia, Mr. Restaino and Mr. Moscaritola voting nay:

WHEREAS, the Public School Contracts Law (Ch. 114, Laws of 1977) provides for the award of contracts for this type of professional service without competitive bidding,

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Township of Nutley as follows:

- 1. The firm of Deloitte & Touche LLP of Morristown, NJ is hereby appointed auditors for the accounts of the Board of Education for the 1999/2000 school year.
- 2. This contract is awarded without competitive bidding as a professional service under the provisions of the Public School Contracts Law.

Mr. Moscaritola said that in his opinion all that had happened was that we had not approved last year's auditor and felt that this matter could wait. Mr. Sincaglia indicated that in his opinion it was necessary to make a decision so that the financial business of the school district could proceed in a normal manner.
