ANNOUNCEMENT OF MEETING:

APPOINTMENT - Professional Staff:

Dr. Casale presented and moved the adoption of the following resolution, seconded by Mr. Pelaia:

Mrs. Russo asked some questions relating to this particular item and other items on the agenda in terms of the timeliness.

Mrs. Fleitell entered during this discussion

BE IT RESOLVED, That the Board of Education approves the appointment of Mr. Thomas Cenicola as teacher for the 1999/2000 school year effective November 16, 1999, at the annual salary of \$40,995, M.A.-17(p/t 2/3), in accordance with the 1999/2000 Teachers' Salary Guide.

On a roll call vote the resolution was unanimously adopted.

APPOINTMENT - Teacher Substitute:

Miss Maria Vagias

Mr. Cafone presented and moved the adoption of the following resolution, seconded by Mr. Pelaia. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Miss Maria Vagias be appointed as teacher substitute for Business Education, effective November 16, 1999 at the per diem rate of \$65, in accordance with the per diem rate established by the Board of Education.

BE IT FURTHER RESOLVED, That the Board approves the application for emergency hiring of Maria Vagias as per the state criminal review procedure.

APPOINTMENT - Part-Time Aide:

Mrs. Catherine Isabella

Mrs. Russo presented and moved the adoption of the following resolution, seconded by Dr. Casale. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Mrs. Catherine Isabella be appointed part-time school aide, retroactive to September 27, 1999, for the 1999/2000 school year, at the hourly rate of \$10.60, Step 1, in accordance with the hourly rate established by the Board of Education.

APPOINTMENT - Cafeteria:

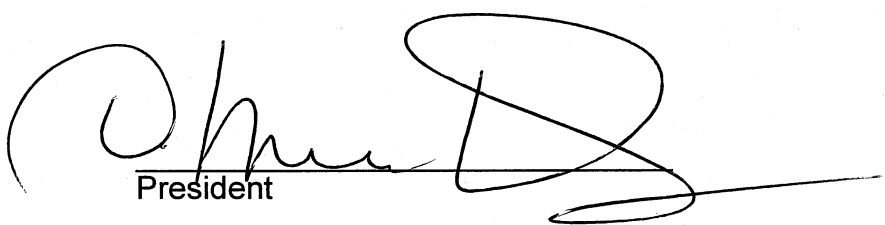
Mrs. Dora Farro

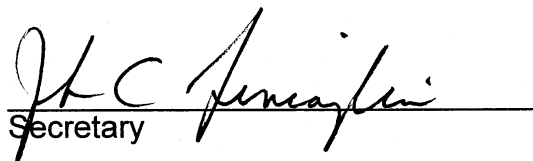
Mr. Picciano presented and moved the adoption of the following resolution, seconded by Mrs. Fleitell. On a roll call vote the resolution was unanimously adopted:
