# Board of Education Nutley, NJ

The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey was held in the Franklin School Auditorium, 325 Franklin Avenue, on Monday, February 26, 2001 at 8:10 p.m. with Mr. Alfred R. Restaino, Jr., President, presiding.

# **ANNOUNCEMENT OF MEETING:**

Mr. Restaino read the following:

Dr. Casale led the Board members and citizens in the Pledge of Allegiance to the American flag.

# CALL OF ROLL:

The other members present at roll call were: Mrs. Maria Alamo, Mr. John Cafone, Dr. Philip T. Casale, Mrs. Michele Fleitell, Mr. Joseph C. Pelaia, Mr. Steven P. Picciano, and Mrs. Agnes Roncaglio. Absent: Mr. Vincent A. Moscaritola. Approximately 125 citizens were present.

#### PRESENTATION OF AWARDS:

Dr. Serafino welcomed everyone present this evening and stated she was very proud of the district's outstanding students who have accomplished some highly-regarded achievements, both in athletics and academics. She extended compliments to all the students, commended scholars and National Merit Finalists. Dr. Serafino indicated that she was certain all the parents are very proud, as we in the district are proud. She then introduced Ms. Judith Hubert, High School Guidance Coordinator.

Ms. Hubert explained that high-achieving students in the Garden State Scholars program are designated Edward J. Bloustein Distinguished Scholars and are in the top 10% of their class with a minimum SAT of 1260 or rank first, second or third in their class at the end of the junior year. She further noted that these students attained an average of 666 in the verbal portion of the test and 686 in the math portion. Ms. Hubert indicated that the Commended Students are sponsored by the National Merit Scholarship Program and 1.1 million students took the PSAT in October of 1999. She commented that Commended Students are in the 95<sup>th</sup> percentile and out of the 1.1 million students taking the test, only 34,000 qualified.

# HEARING OF CITIZENS:

<u>Mrs. Barbara Bochese</u>, 50 Cedar Street, read the following statement:

"I will recognize that authority rests with the board of education and will make no personal promises nor take any private action which may compromise the board.

"I will refuse to surrender my independent judgment to special interest or partisan political groups or to use the schools for personal gain or for the gain of friends.

"I will hold confidential all matters pertaining to the schools which, if disclosed, would needlessly injure individuals or the schools. But in all other matters, I will provide accurate information and, in concert with my fellow board members, interpret to the staff the aspirations of the community for its schools.

"What I have just read to you are three of The New Jersey Board's Code of Ethics. I have read them to you as a reminder of your responsibilities as a school board member in light of the following:

"Two years ago, I brought very serious concerns and allegations I had discovered regarding the newly hired varsity ice hockey coach to the attention of the administration. Dr. Serafino promptly responded to my concerns and immediately contacted specific members of the Board. Within 48 hours of receipt or knowledge of my letter by specific board members, certain individuals not on the board were in receipt of the information contained in my letter and the fact that I had sent a letter to Dr. Serafino. Fast forward two years later and once again I attend a school athletic event to hear these same individuals make the most contemptible and inappropriate comments to the school bus driver and the wife of the new coach. To tell the bus driver that he should look for another job because he won't be back next year or to tell the wife of the coach that her husband should also look for another job because he won't be back is simply outrageous. I realize you cannot be held responsible for what your ill-mannered friends say but you should be held responsible for what information you empower your friends with. I cannot prove and you cannot disprove what I have just alleged, however, I hope by bringing this out in the open it will remind all of you of your responsibilities to every Nutley citizen and student and how your actions can hurt innocent individuals.

"Two meetings ago I asked the Board to respond to my concerns regarding the inflated pricing of food items sold to students at Franklin Middle School. The Board allowed Mr. Sincaglia to respond in which he replied that this is no "profit" and in fact the food service department has run a deficit in the past year. May I respond to Mr. Sincaglia's rather deficient comments:

- a. Mr. Sincaglia has presented to this Board a budget that includes all estimated costs associated with the running of the food service department. If indeed as Mr. Sincaglia has stated that department has run a deficit for the past years, then someone is not running their department efficiently and certainly not accountable to the taxpayers who accept the budget this Board presents to them year after year.
- b. May I remind Mr. Sincaglia that when you charge \$1.10 for a can of Snapple and you pay 35 cents for it there is a clear profit of 75 cents. What the school administrator decides to do with all the monies or profits derived from inflating the costs of goods is a question. If Mr. Sincaglia has the discretionary ability to inflate the costs of goods, and possibly generate more than \$150,000 dollars in additional revenue for the food service department the real deficit or under budgeted dollar amount is even greater than what is shown at the end of the year.
- c. All Nutley taxpayers share equally the burden of the costs to run this district that includes the food service department. To place the burden on a small population of children and their parents that are forced to purchase these items because of a closed lunch program is simply shocking.
- d. May I also remind you that we are talking potentially over the course of the past five years, hundreds of thousands of dollars in cash to be accountable for. May I remind you I said cash.
- e. Just how much does it cost to run the food service department? Board members, you really don't know. If the food service department runs over budget year after year and Mr. Sincaglia has been able to reduce that deficit by padding it with revenue generated by inflating the costs of goods, then we have a bigger problem that I originally thought. This Board has a responsibility to review the food service budget, determine the cause of it going over budget and what is that exact amount it costs to run that department.

f. Finally, this board has an obligation to every taxpayer and specifically to those Franklin School parents who have been forced to pay what is in affect, additional tax dollars for the highly inflated costs of food items which based on

a low estimation of \$1.00 per day per student can add up to an additional tax outlay by Franklin School parents of approximately \$180.00 per school year. I request that this Board review all expenditures of the Food Service Department, the vendors it uses, the handling of cash receipts, the monitoring of sales to the remaining inventory, the real needs of each cafeteria based on student consumption, and review for waste and inefficiencies. This Board must also decide if it will allow the pricing of goods to be based on the needs of an erroneously presented budget of this department rather than what the market would allow."

Mr. Sincaglia replied that the cost of the cafeteria program has a substantial overhead with regard to salaries and benefits for the cafeteria workers. Cafeteria personnel get essentially the same raises and benefits as everyone else in the district, and the cost of personnel in the department is in excess of the sale of food. In 1999, \$387,856.00 was taken in from the sale of food to students and staff. The cost of salary and benefits alone was \$414,798.00, this did not include the cost of food. If lower prices were charged, the taxpayers' deficit would be even larger. The Board of Education in order to fill the gap in cost had to contribute a total of \$153,878.00 last year. This amount was down from \$172,000.00, which was paid the year before. The Board also is subsidized by the state and federal government, but that alone does not equal the overhead cost. He personally feels taxpayers need to pay for the educational costs of the students not subsidize the cost of snacks. He stated that if the Board wanted to make a different decision it is free to do so, but he did not believe it would be a sound use of educational dollars.

Mrs. Bochese questioned if the entire food service budget, as well as salaries, is all inclusive in the cost of goods. She asked Mr. Sincaglia to clarify the fact that what the children are being charged is not meeting the needs of the food service budget. She also asked if the cost of goods will be increased to cover the cost of salaries. Mrs. Bochese felt it would be more "cost effective" if the anticipated deficit was spread through all the schools and not just certain schools.

Mr. Sincaglia replied that the cost of lunch is the amount allowed by the state, and it differs among elementary, middle and high school.

Mrs. Bochese stated that when the children are in a closed lunch they have to pay what the market will bear because they are unable to go anywhere else. The children do not get the chance to "shop around." She finds the cost to be arbitrary and extremely discriminate. She stated she is also enlightened to know that the cost for the food service is where they derive the budget to cover all the expenses of the food service, including salaries and benefits.

Mr. Sincaglia responded that the state insists that it be done that way, he did not create the system.

<u>Maria Russo</u>, 251 High Street, asked for clarification regarding the salaries of the food service department. She asked if the salaries included the Food Service Director. She also asked for a breakdown of food income per school in the district. She stated that the education of our students is very important, however, the environment in which they eat lunch is equally important. She strongly feels that this is the area where we must look at the dollars and cents spent in our food services and what is provided. She feels looking at the lunch program is as important as reviewing curriculum on a daily basis. She stated that this is where the children spend a part of their day and for them to have a good social environment, as well as a good home environment, aids academic improvement.

Mrs. Russo also asked about the school crossing guards cost. She stated that the Board has shared in the expense of the crossing guards paying an amount of approximately \$200,000 per year, but felt it should be the sole responsibility of the Public Safety Department. She stated that a little over \$2 million dollars has been going to crossing guards within the last 10 years and that money could have been going to the education of the children.

Mrs. Russo asked the Board to review their banking. She stated that she really thinks banks will come out and be more competitive, which would benefit the Board.

#### OLD BUSINESS:

None

#### NEW BUSINESS:

A motion was made by Mr. Pelaia, seconded by Mrs. Roncaglio and unanimously approved by the Board to cancel the March 26, 2001, Regular Board Meeting and move it to March 29, 2001, at 7:00 p.m. for the purpose of the Regular Board Meeting and the public hearing of the 2001-2002 budget.

Mr. Pelaia made a motion for the Board to convene for a Special Meeting on March 2, 2001, at 7:00 p.m. at Franklin Middle School Auditorium for the purpose of adopting the tentative budget for the 2001-2002 year, seconded by Mrs. Roncaglio and unanimously approved by the Board.

Mr. Picciano thanked the citizens of Nutley for the opportunity to serve them. He stated his reason for not running for the Board of Education is due to priorities and responsibilities beyond the realm of public service. He went on to quote his 13 year old son who said, "Leadership is not about individual goals and accomplishments, but rather its about achieving goals that are in the best interest and the welfare of many others."

Mr. Picciano expressed some disappointments he encountered while being on the Board. He felt one of them being that in a town this size there are not a lot of people running for the Board, and we need to get more people involved. He also felt that while looking at a referendum to improve the school district, he is not totally sure if they exhausted every possibility of what could be done.

Mr. Picciano thanked his fellow Board members and wished the incoming Board members best wishes.

Mr. Restaino thanked Mr. Picciano for the time he dedicated to the Town and the things that have been accomplished collectively and wished him the best in all his endeavors.

Mrs. Alamo stated that she had the opportunity to attend two full weekend sessions given by the New Jersey School Board Association (NJSBA). The first one being the session that all new Board members attend. The second session was on advanced Board membership. She stated that she learned so much from Board members all over the state, as well as the Principal of Northern Valley

Regional High School. She recommended that we bring the NJSBA into the district, since they offer in-services to the district. Mrs. Alamo thanked the district and Mr. Sincaglia for giving her the opportunity to attend the seminar. She also thanked all her fellow Board members for their mentoring while she is wrapping up her first year on the Board.

Mrs. Roncaglio mentioned that one of our Nutley High School hockey players, James Maganaro, is the first player from the New Jersey Interscholastic League-America C Division and the first player from Nutley High School to make the high school senior all star team. He is also the only defense men in the top 20 scorers in the state. She wished him and his teammates continued success.

Dr. Casale had several questions concerning the budget. One of the questions being what an encumbrance account meant.

Mr. Sincaglia explained that an encumbered account meant that at the end of the fiscal year purchase orders that have been issued but have not been fulfilled become an encumbrance, which by GAP regulations, gets rolled into the next year's budget. There are always some encumbrances at the end of the year and the state indicated that if this occurs you have to roll it into the following year's budget.

Dr. Casale asked questions concerning the cafeteria budget account and Mr. Sincaglia responded with an in-depth description of the account.

Dr. Casale asked about a possible venture with Coca-Cola Bottling Company which might produce additional revenue for the school district.

Mrs. Alamo commended Mr. Sincaglia, Mr. Pelaia and the Budget Committee for what she knows to be a tedious job.

Mrs. Fleitell read the following statement:

"As you know, I have decided to not seek re-election in April. During the past 6 years of my tenure, I have witnessed the change in leadership of the superintendent and assistant superintendent, twice, and the appointment of new principals to every school in the district, as well as the appointment of other administrators and newly created positions. I challenge every one of you to take this district to new heights academically and effectively. Remember, our product is people. We cannot take some off the assembly line and begin all over. Everything we do affects the future of our children and of our community. We have good schools, we must continue to make them even better, to provide opportunities for our children to compete and be successful in all of their endeavors.

"I support the athletic program in the district, and I support the coaches, and I believe that they have to run their programs with autonomy, integrity and discipline, just as every teacher in the district is expected to run her classroom. What is being taught on the athletic fields are life skills lessons as well as skills to win. Oftentimes, those skills have the most important impact on students' lives. I encourage the board and the administration to see that a weight room is up and running by June of this school year. It can be done. There is no reason to have to wait until a permanent facility is constructed under the upcoming building expansion Our athletes need to have a facility in which to train in order to be physically fit and prepared to compete in the tough NNJIL conference. More than half of the high school population is involved in some athletic activity. "I encourage the continued dialogue regarding curricular changes and new courses at the high school, not only in math and science, but also including the liberal arts, as well as transcript and GPA changes. I only caution that appropriate change sometimes needs to be phased in, in order that freshmen come in and leave under the same set of rules. Freshmen enter high school already knowing what they need to do to achieve their own goals. It seems unfair to change the rules after they have entered.

"I ask the superintendent to again look into modification of the elementary school lunch program. One hour for lunch is an archaic plan going back to a time when almost all mothers were home with their children and there was no facility for lunch in the schools. Now over 75% of the children eat lunch in school daily. The lunch period could be more effectively and safely run if cut down to 40 minutes. The entire school does not need to have lunch at the same time. In most schools, the children are already divided into eating times. This would cut the amount of time children are in a large, minimally supervised situation on playgrounds or inside. More difficulties occur during the lunch break than during school time. Suggestions for implementation might be to add additional physical education, art or music time to the curriculum, or cut 15 minutes from the end of the school day. Whatever the superintendent believes might work best should be implemented. It should be looked into in a serious manner.

"Last, but certainly not least, I wish my fellow BOE members good luck with the challenges ahead, especially with the major undertaking of the building expansion program. Keep the children in mind. I'm sure you will make the right decisions that will benefit the children and the community. I also wish to thank all who have encouraged and supported me over the years. It is my honor to have served this community and this school district."

Mr. Restaino thanked Mrs. Fleitell personally as well as from the Board, for the past six years of service on the Board.

#### RESOLUTION TO CLOSE MEETING TO THE PUBLIC:

Mr. Restaino asked Mr. Sincaglia to read the following resolution:

WHEREAS, the Board of Education will be discussing matters exempt from public discussion pursuant to N.J.S.A. 10:4-12,

NOW, THEREFORE, BE IT RESOLVED, That the Board of Education adjourn to closed executive session at this time to discuss legal matters, matters of personal privacy and contract negotiations, and

BE IT FURTHER RESOLVED, That the results of the discussions will be made public by inclusion on the agenda of a subsequent meeting of the Board of Education or when the reasons for discussing such matters in closed session no longer exist.

Mrs. Roncaglio moved that the resolution be adopted, seconded by Mr. Cafone and unanimously approved by the Board.
