President Casale thanked the Budget Committee and Administrators for their diligence in establishing the proposed 2010-2011 School District Budget. He then introduced Acting Board Secretary Karen Yeamans who gave a detailed power-point presentation of the proposed 2010-2011 budget.

Mr. Zarra spoke about the 2010-2011 School District Budget and the cuts necessary due to the state aide funding next year.

ADOPTION OF 2010-2011 BUDGET

ADOPT 2010-2011 BUDGET

Trustee Kuchta moved, and Trustee Sautter seconded, that the Board approve the following resolution. Upon a roll call vote the budget was unanimously approved.

WHEREAS, the Board of Education of the Township of Nutley adopted a tentative budget for the 2010-2011 school year on March 22, 2010, and

WHEREAS, said tentative budget was properly advertised on March 25, 2010, and

WHEREAS, the Public Hearing on the budget was conducted on March 31, 2010,

NOW, THEREFORE, BE IT RESOLVED that the Board of Education hereby adopts the official budget for the 2010-2011school year in the following amounts:

General Fund	\$ 52,935,482
Special Revenue Fund	1,531,181
Debt Service Fund	<u>3,742,330</u>
Total Budget	\$ 58,208,993

Of which the following amount shall be raised by local tax levy:

General Fund Tax Levy	\$ 47,198,664	
Debt Service Tax Levy	2,913,940	
Total Tax Levy	\$ 50,112,604	

and,

BE IT FURTHER RESOLVED that the Secretary be authorized to place on the ballot at the Annual School Election to be held on April 20, 2010 the proposal to approve the General Fund tax levy portion of the 2010-2011 school budget. The complete budget for 2010-2011 is on file in the Business Administrator's Office.

DISTRICT TRAVEL

2. 2010-2011 BUDGET SCHOOL DISTRICT TRAVEL MAXIMUM

Trustee Rogers moved, and Trustee Kuchta seconded, that the Board approve the following resolution. Upon a roll call vote the resolution was unanimously approved.

WHEREAS school district By-Law 0147 Board Member compensation and Expenses, Policy 3440 Teaching Staff Members Job Expenses and Policy 4440 Support Staff Members Job Expenses, and NJAC 6A:23b-1.2(b), provide that the Board of Education shall establish in the annual school budget a maximum expenditure amount that may be allotted for such travel and expense reimbursement for the 2010-2011 school year, and

WHEREAS the tentative budget adopted by the Board of Education on March 22, 2010 included funds for travel and travel-related expenses in accordance with the above by-law, policies and NJ Administrative Code Regulations,

NOW BE IT RESOLVED that the Board of Education hereby establishes the school district travel maximum for the 2010-2011 school year in the sum of \$35,600 as contained in the appropriate budgetary accounts, and

ALSO BE IT FURTHER RESOLVED that the Board Secretary/Business Administrator shall track and record these costs to insure that the maximum amount is not exceeded.
