### STATEMENT OF RESULTS OF ANNUAL SCHOOL ELECTION

On Tuesday, November 4, 2014 the Annual School Board Election for the Nutley School District was held. Voting was conducted for the election of three members to the Board of Education for a three-year term. The results of the election were as follows:

The candidates elected were Fredrick Scalera, Salvatore Ferraro and Lisa Danchak-Martin for a three-year term.
