Ms. Martin gave a power-point presentation on the Mathematics program review.

Ms. Greco gave a power-point presentation on the strategic plan survey.

President Carnicella and the entire Board of Education recognized Trustee Kucinski for his service during the Vietnam War.

## SUPERINTENDENT'S REPORT

Dr. Glazer recognized Doreen Holland who was chosen for the 2018 Women's Advocacy Award for her contributions to the school and Nutley community through the Spring Garden Military Fan Club. She congratulated the Music Department for being voted by the NAMM as one of the best communities for music education. Dr. Glazer also spoke about the Homeland Security Team and said a speaker will be at the May 21, 2018 Board Meeting to speak of their findings. She spoke about the Strategic Plan with Dr. Librera and the Budget Hearing that will take place at the May 7,

2018 Board Meeting. She also spoke of the activities taking place throughout the town and school district.

## **BOARD SECRETARY'S REPORT**

Mr. Marmora stated that April serves as the beginning of the financial transition from the 2017-2018 to 2018-2019 school year and the finalized 2018-2019 budget will be presented at the May 7, 2018 Board Meeting. He reported that the Department of Agriculture conducted an Administrative Review for the district's Food Services and an exit conference is scheduled for this Wednesday. He also said progress continues to be made with the Washington School Secure Entrance.

#### STUDENT REPORT

Huatao (Tao) Chen, Student Representative, reported on past and upcoming events taking place in the high school.

#### **COMMITTEE REPORTS**

Academic Committee – Trustee Balsamo said that Dr. Ruggerio presented the full Program Review Report for World Languages. Ms. Martin and consultant, Bill Jackson, presented the Program Review Report for Mathematics. Mrs. Loconsolo and Mr. Bania provided an update on the Extended Day Program review and also went over the schedule for the staff professional learning on April 25, 2018. Dr. Glazer provided an update on the security assessments and on the budget. Dr. Glazer also reviewed the structure for developing the Strategic Plan, personnel and legal updates.

Administrative Committee – Trustee Kucinski said the committee discussed the budget, including health care, the security visits by the Homeland Security Team and additional trailers. Dr. Glazer reviewed the continued updates to building access. Negotiations between the BOE and EAN will start at the beginning of May. Dr. Glazer gave an overview of the Strategic Plan and provided an update on personnel and legal issues.

Finance Committee – Trustee Kline said that Joe Dicara from Dicara Rubino updated the committee on the Washington School Security entrance project and presented options for security entrances at Yantacaw and JHWMS. Mr. Nicolette discussed potential summer projects and the status of current work orders. Mrs. Yeamans and Dr. Glazer reviewed the tentative budget including staffing for the 2018-2019 school year. The committee reviewed the Finance Resolutions and Mr. Marmora explained the budget transfers. Mrs. Yeamans informed the committee about the temporary relocation of the larger buses during baseball season.

Policy Committee – Trustee Sherman said the committee reviewed the policies to be presented at tonight's meeting for the First Reading. The committee discussed the upcoming policies to be reviewed. Dr. Glazer provided an update on personnel, legal and security issues.
