2. <u>AUTHORIZATION TO ALLOCATE FUNDS FROM CAPITAL RESERVE</u>

BE IT RESOLVED that the Board of Education is hereby formalizing its intent to move forward with the following capital projects barring any future financial requirements for operation of the district. This includes allocating an additional \$300,000 to the funds already allocated and approved for the Nutley Oval Project, \$600,000 for the Yantacaw School secure entrance, and \$200,000 for restoration and enhancement of the Nutley High School Library, Media Center space.

The Board of Education authorizes the Business Administrator to appropriate funds in the amount of \$1,100,000 from Capital Reserve earmarked for these projects.

3. <u>AUTHORIZATION TO ALLOCATE FUNDS FROM MAINTENANCE RESERVE</u>

BE IT RESOLVED that the Board of Education is hereby formalizing its intent to move forward with the following maintenance projects barring any future financial requirements for operation of the district. This includes allocating \$250,000 for safety and security enhancements throughout the district.

The Board of Education authorizes the Business Administrator appropriate funds in the amount of \$250,000 from Maintenance Reserve earmarked for these projects.
