Trustee Kucinski moved, Trustee Reilly seconded, and the following Board minutes were unanimously approved.

Reports as follows:

1. Superintendent's Report

Mr. Bania starting his report by thanking many people publicly who helped support the district after the Lincoln School fire. Mr. Bania discussed what transpired and how the district was able to come together and get Lincoln school back up and running in four days. Mr. Bania continued by mentioning many events going on in the district. The concert choir performed at the Montclair State Choir Festival: based on their performance they were asked to be one of the two choirs to perform at the Montclair spring concert. Mr. Gains was selected for the Eric Whitacre residency at Montclair State and his chamber singers were selected to perform at the NJMEA music conference. Mr. Bania said regarding athletics the girls' volleyball team had a play off game last week and the Nutley football team has won the three of their last four games, which ends their football season on a very positive note. Our girl's tennis team won the Colonial Championship and our girls cheerleading squad won a SEC Championship. Mr. Bania said our Third Half Club ran a fundraiser called the Taste of Nutley at the Nutley Elks Club. On October 19th the district held a bi-lingual parent advisory meeting and the guidance department held a very successful college admission panel meeting. Mr. Bania congratulated Mr. David DiPisa for presenting at the NJ School Boards Conference. Mr. Bania thanked the NEF for visiting our schools and presenting their grants. Mr. Bania gave some facility updates; the Nutley High School weight room is close to completion and our High School Media Center and Stem lounge is still on target for a December opening. The St. Paul's Early Childhood Center hopes to be complete by December 2023. Mr. Bania said the Nutley High School held its annual blood drive and Halloween Dance. Mr. Bania continued by mentioning some important dates and district information. On Halloween there will be a 12:30pm dismissal for elementary schools and a return to school time of 2:45pm for the elementary Halloween parades.

14. <u>AUTHORIZATION TO SUBMIT 2023/2024 COMPREHENSIVE MAINTENANCE PLAN</u> <u>& M-1- 2023-2024</u>

WHEREAS the Department of Education requires New Jersey school districts to submit a three-year maintenance plan documenting "required" maintenance activities for each of its public- school facilities, and

WHEREAS the required maintenance activities as listed in the document for the various school facilities of the Nutley Board of Education are consistent with these requirements, and

WHEREAS all past and planned activities are reasonable to keep school facilities open and safe for use in their original condition and to keep their system warranties valid,

NOW, THEREFORE IT BE RESOLVED that the Nutley Board of Education hereby authorizes the School Business Administrator to submit the 2023-2024 Comprehensive Maintenance Plan and M-1 for the Nutley School District in compliance with Department of Education requirements.

15. ANNUAL TOILET ROOM FACILITIES FOR EARLY INTERVENTION, PRE-KINDERGARTEN AND KINDERGARTEN CLASSROOMS 2023-2024 SCHOOL YEAR

Toilet facilities for preschool and kindergarten classrooms shall be provided as follows: i. An individual toilet room shall be provided in each classroom and shall meet the following criteria:

(1) Be located and equipped in such a way as to ensure privacy for the students;

(2) Be accessible to physically disabled students and barrier free in design as per N.J.A.C. 5:23-7; 115

(3) Be equipped with an open front seat with a flood rim height no greater than 14 inches from the floor, and a lavatory (sink) with a flood rim height no greater than 26 inches from the floor.

ii. In lieu of providing an individual toilet room in each classroom as required in (h)4i above, toilet rooms may be provided adjacent to or outside the classroom if the following criteria are satisfactorily addressed:

(1) No child or group of children shall be left unsupervised at any time when traveling to or from the facilities.

(2) Provisions shall be made for adult supervision in a manner that will not infringe upon instructional time;

(3) Toilet facilities shall be readily accessible and the toilet room and signage shall be visible to a child from the classroom door;

(4) Toilet facilities shall be provided for both boys and girls and shall meet the requirements of (h) 4i (4) above.

iii. If a school district chooses to provide toilet rooms adjacent to or outside the classroom in conformance with (h)4i above, the chief school administrator shall certify to the executive

county superintendent on forms prescribed by the Commissioner how the alternate method of compliance shall be addressed. The completed form and a copy of a resolution by the district board of education approving the alternate method of compliance shall be submitted to the executive county superintendent for approval.

iv. Thereafter, the chief school administrator annually shall resubmit the form certifying how the alternate method of compliance will be addressed. Any changes to the approved alternate method of compliance shall be submitted to the executive county superintendent for approval.
