21. FOOD SERVICES MANAGEMENT FOR 2024-25 SCHOOL YEAR

WHEREAS, on March 12, 2024, the Nutley Board of Education (the "Board") issued a public Request for Proposals for food service management services (the "Services"); and

WHEREAS, on or about April 9, 2024, the Assistant School Business Administrator caused all received sealed proposals for the Services to be opened and submitted to a proposal evaluation committee (the "Committee"); and

WHEREAS, the Board received proposals from Southwest Foodservice Excellence, LLC ("Southwest") and Pomptonian Food Service ("Pomptonian") to provide Services for the 2024-2025 school year; and

WHEREAS, the Committee scored the Southwest and Pomptonian proposals based on various fiscal parameters and concluded that the Southwest proposal was most financially advantageous for the Board, but the Committee did not evaluate the proposals in light of prior experience and practical considerations; and

WHEREAS, the Board has contracted with Pomptonian in prior years which provided the Services in an efficient and satisfactory manner with positive feedback received from students and parents; and

WHEREAS, Southwest is located in Scottsdale, Arizona and Pomptonian is located in Fairfield, New Jersey; and

WHEREAS, the Board has not contracted with Southwest and has significant concerns regarding its remote location and ability to provide satisfactory Services to the District; and

WHEREAS, the Board finds and declares that based upon prior positive experience and demonstrated capabilities, Pomptonian is better situated and suited to provide the Services to the District than Southwest.

NOW, THEREFORE, BE IT RESOLVED by the Nutley Board of Education that a contract for Food Service Management be awarded to Pomptonian Food Service located at 155 Passaic Ave, Suite 210, Fairfield, NJ 07004 ("Pomptonian"); and

BE IT FURTHER RESOLVED that said contract shall be awarded subject to the following contractual provisions:

The contract shall be awarded for the 2024-2025 school year, with an option for two (2) one (1) year extensions thereafter, at the Board's discretion, and subject to the same terms and conditions as the base contract.

Pomptonian shall receive, in addition to the costs of operation, a fee of \$0.2507 per reimbursable meal and meal equivalent to compensate the Food Service Management Company for administrative and management costs. This fee shall be billed monthly as the cost of operation. The district guarantees the payment of such costs and fee to Pomptonian. The 2024-2025 Total Cost of the Contract is projected to be \$1,191,888.51, as found on the Response and Projected Operating Statement (Form 23)

The number of National School Lunch Program, and if applicable, Breakfast Program, At-Risk Afterschool Meals Program and After School Snacks Programs, meals served to children shall be determined by actual count. A "Meal Equivalent" provided by Pomptonian is determined by dividing the total of cash receipts, other than from sales of National School Lunch Program, and if applicable, Breakfast Program, At-Risk Afterschool Meals Program and After School Snacks Programs, meals, or Cash Equivalents, by the Equivalency Factor. The Equivalency Factor used to determine the number of Meal Equivalents served by Pomptonian shall be the amount of \$4.70.

The per meal management fee of \$0.2507 will be multiplied by total meals.

Pomptonian guarantees that the return to the District from the Food Service Program for the school year will be \$25,000. If the annual operating statement shows a return of less than \$25,000, Pomptonian will pay the difference between the actual and the guaranteed amount. Financial terms of the Contract are based upon the assumptions as stated in Section II A, Paragraph 8, and Section BBB (Guarantee Conditions and Assumptions) in the Contract. If there is a change in conditions, including, without limitation, changes to the preceding assumptions, the parties agree to enter negotiations concerning the impact of such changes, and the financial terms of the Contract, including any guarantee, shall be adjusted accordingly.
