8. <u>APPROVAL OF FOOD SERVICE MANAGEMENT COMPANY FOR 2025/2026 SCHOOL</u> YEAR

BE IT RESOLVED that the Nutley Board of Education "SFA" awards the contract for Food Service Management to The Pomptonian, Inc. "FSMC" for the food service operation for 2025-2026.

1. FSMC Fee:

The FSMC shall receive, in addition to the costs of operation, an administrative/management fee of \$0.2810 per reimbursable meal and meal equivalent to compensate the FSMC for administrative and management costs. This fee shall be billed monthly as a cost of operation. The SFA guarantees the payment of such costs and fee to the FSMC.

Total meals are calculated by adding reimbursable meal pattern meals served and meal equivalents. The number of reimbursable meals served to the children shall be determined by actual count. Cash receipts, other than from sales of reimbursable program meals served to the children, shall be divided by \$4.89 to arrive at an equivalent meal count.

The per meal administrative/management fee of \$0.2810 will be multiplied by total meals.

- 2. The FSMC guarantees a minimum return of \$50,000.00
- 3. Total Estimated Cost of Contract:

Total expenses (cost) include food, labor, supplies, other expenses, and FSMC management fee.

The Total Estimated Cost of Contract is \$1,251,919.73
