12. AUTHORIZATION TO SUBMIT 2025/2026 COMPREHENSIVE MAINTENANCE PLAN & M-1

WHEREAS the Department of Education requires New Jersey school districts to submit a three- year maintenance plan documenting “required” maintenance activities for each of its public- school facilities, and

WHEREAS the required maintenance activities as listed in the document for the various school facilities of the Nutley Board of Education are consistent with these requirements, and

WHEREAS all past and planned activities are reasonable to keep school facilities open and safe for use in their original condition and to keep their system warranties valid,

NOW, THEREFORE IT BE RESOLVED that the Nutley Board of Education hereby authorizes the School Business Administrator to submit the 2025/2026 Comprehensive Maintenance Plan and M-1 for the Nutley School District in compliance with Department of Education requirements.

13. ANNUAL TOILET ROOM FACILITIES FOR EARLY INTERVENTION, PRE - KINDERGARTEN AND KINDERGARTEN CLASSROOMS 2025/2026 SCHOOL YEAR

Toilet facilities for preschool and kindergarten classrooms shall be provided as follows:

1. An individual toilet room shall be provided in each classroom and shall meet the following criteria:
 - a. Be located and equipped in such a way as to ensure privacy for the students;
 - b. Be accessible to physically disabled students and barrier free in design as per N.J.A.C. 5:23-7; 115
 - c. Be equipped with an open front seat with a flood rim height no greater than 14 inches from the floor, and a lavatory (sink) with a flood rim height no greater than 26 inches from the floor.
2. In lieu of providing an individual toilet room in each classroom as required in (h)4i above, toilet rooms may be provided adjacent to or outside the classroom if the following criteria are satisfactorily addressed:
 - d. No child or group of children shall be left unsupervised at any time when traveling to or from the facilities.
 - e. Provisions shall be made for adult supervision in a manner that will not infringe upon instructional time;
 - f. Toilet facilities shall be readily accessible and the toilet room and signage shall be visible to a child from the classroom door;
 - g. Toilet facilities shall be provided for both boys and girls and shall meet the requirements of (h) 4i (4) above.
3. If a school district chooses to provide toilet rooms adjacent to or outside the classroom in conformance with (h)4i above, the chief school administrator shall certify to the executive county superintendent on forms prescribed by the Commissioner how the alternate method of compliance shall be addressed. The completed form and a copy of a resolution by the district board of education approving the alternate method of compliance shall be submitted to the executive county superintendent for approval.
4. Thereafter, the chief school administrator annually shall resubmit the form certifying how the alternate method of compliance will be addressed. Any changes to the approved alternate method of compliance shall be submitted to the executive county superintendent for approval.

WHEREAS, the Northern Region Educational Services Commission, hereinafter referred to as the "Lead Agency" has offered voluntary participation in a Cooperative Pricing System for the purchase of goods and services;

WHEREAS, on November 3, 2025, the governing body of the Nutley Board of Education, County of Essex, State of New Jersey, duly considered participation in a Cooperative Pricing System for the provision and performance of goods and services;

NOW, THEREFORE BE IT RESOLVED as follows:

TITLE

This RESOLUTION shall be known and may be cited as the Cooperative Pricing Resolution of the Board of Education.

AUTHORITY

Pursuant to the provisions of N.J.S.A. 40A:11-11(5), the School Business Administrator is hereby authorized to enter into a Cooperative Pricing Agreement with the Lead Agency.

The Lead Agency shall be responsible for complying with the provisions of the Local Public Contracts Law (N.J.S.A. 40:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey.

EFFECTIVE DATE

This resolution shall take effect immediately upon passage.

WHEREAS, the Northern Region Educational Services Commission was established in accordance with N.J.S.A. 18A:6-52 and as such is considered a "district" as defined in N.J.S.A. 18A:18A-2.d of the Public School Contracts Law, and

WHEREAS, in accordance with N.J.S.A. 18A:18A-5.b, districts may enter into contracts with the Commission without bidding; and, according to N.J.S.A. 18A:18A-37.a, solicitation of quotations is not required to award contracts with the Commission, and

WHEREAS, in addition, districts may contract with the Commission to provide any and all services in accordance with N.J.S.A. 6-63.a.
